Under the [Raytheon Technologies Corporation \(RTX\) Business Gifts from Suppliers Policy](#), all employees and contractors of RTX and its business units, including Pratt & Whitney, are prohibited from soliciting gifts, entertainment and gratuities. Additionally, those employees and contractors who have direct or indirect purchasing responsibilities for Pratt & Whitney, or may influence our supplier selection, are prohibited from accepting gifts, entertainment and gratuities from anyone seeking business with us.

We take this policy seriously and enforce it vigorously, and we expect our suppliers to do the same, so please communicate its requirements to all within your organization who may have business dealings with employees and contractors of Pratt & Whitney.

As you know, we work closely with our suppliers to maintain a world-class, integrated supply chain, and we demand that our suppliers meet our high standards for ethical business practices. These expectations are set forth in the RTX Supplier Code of Conduct, which aligns with the expectations we have of our own directors, officers, employees and representatives.
