Hetmańska 120, Rzeszów, Poland; Pratt & Whitney Tubes sp. z o.o. (PWT), ul. Grabska 4, Niepolomice, Poland as RTX controlled entities are Co-controllers ( in case of commercial relations with mentioned above Poland-based, Raytheon Technologies Corporation companies ) or Controllers of personal data received from business partners as a result of conclusion and performance of business transactions.
2. Co-Controllers or Controllers collect and process necessary personal data of supplier and customer representatives as required by relevant regulations on personal data protection and subsequently retain personal data for period of time required to meet statutory and legal requirements.
3. Personal data will be entrusted for processing, transferred and maintained by RTX service providers outside of the EOG territory based on approved standard clauses of data protection accepted by the European Commission or individual European Commission Decisions and approved Binding Corporate Rules .
