Information Clause on personal data processing

1. The controller for your personal data is": **Pratt & Whitney Tubes Sp. z o.o.** with its registered office in Niepołomice, ul. Grabska 4, 32-005 Niepołomice, entered in the Register of Entrepreneurs of the National Court Register maintained by the District Court for Kraków - Śródmieście in Kraków, 12th Commercial Division of the National Court Register (KRS), under the number KRS 0000230639, with share capital: PLN 11.700.000,00, Tax Identification Number (NIP): 6792835716, (hereinafter: the "Company"), e-mail daneosobowepwt@prattwhitney.com , tel. +48 12 397 10 34
2. Providing the personal data is voluntary, but failure to provide them shall make it impossible to enter the premises of the Company.
3. The processing of the personal data indicated below shall be made under Article 6 (1)(f) of GDPR* - i.e. processing in a legitimate interest of the controller, i.e. to register persons entering the premises of the Company.
4. Your data shall be processed solely for purposes of the cooperation between you and the Company and in order to enable your entry to and moving on the premises of the plant, in accordance with the rules of personal movement applicable in the Company, as well as to demonstrate compliance with the procedures adopted in the Company for personal movement in the event of future audits and inspections.
5. Your personal data may be transferred to entities located outside the European Economic Area (EEA), i.e. located in Canada and the United States of America on the basis of approved Binding Corporate Rules. 6. Upon your consent, the Company may obtain and use your image for identification purposes with an identifier (pass) under Article 6 (1)(a) of GDPR. Granting consent for personal data processing for the above purpose is voluntary and may not be a basis for your unfavourable treatment and also may not cause any negative consequences for you, in particular must not be a reason for refusal of entry to the premises of the Company.
7. The Company shall store personal data for the period of limitation of claims which may arise between the parties. With regard to personal data processing, due to the video surveillance operating on the premises of the Company, the personal data obtained in such manner shall be processed for a period of three months of recording, unless separate regulations state otherwise.
8. **You have the rights to the extent provided for in provisions of law, the right of access to the content of your data, and the right to rectify, erase date, restrict the processing of thereof, to data portability, to make an objection, withdraw consent at any time without prejudice to the lawfulness of processing (if processing is being made with consent) which had been effected by consent prior to its withdrawal.**
9. **You have the right to file a complaint with the President of the Office of Personal Data Protection if you believe that the processing of your personal data infringes the provisions of GDPR.**
