



**Information clause on Personal data processing
(for third parties)**

1. **The administrator of personal data is:** Pratt & Whitney Tubes Sp. z o.o. with its registered office in Niepołomice, Grabska 4, 32-005 Niepołomice, tel. +48 12 397 10 34, registered in the Register of Entrepreneurs of the National Court Register, kept by the District Court for Krakow - Śródmieście in Krakow, XII Commercial Department of the National Court Register, under KRS number 0000230639, with share capital: PLN 11,700,000.00, NIP: 6792835716, (hereinafter: the "Company"). 2. Due to the fact that Pratt & Whitney Tubes Sp. z o.o. is an enterprise engaged in, among other things, production for military purposes subject to specific regulations (Polish and US), we inform persons entering the company that: The Company may process your personal data such as: data on any citizenship you hold, including those relinquished, and data on the country of your current permanent residence permit in order to verify whether you meet the requirements under EAR/ITAR regulations, which is a legitimate interest of the administrator (legal basis: Article 6 (f) RODO*). Provision of the above information is voluntary; however, failure to do so may prevent you from entering the premises.
3. The processing of the personal data indicated below, will be carried out for the purpose of registering your entry into the Company, which is a legitimate interest of the administrator (legal basis of Article 6 (f) RODO*).
4. Provision of personal data is voluntary, but failure to do so will prevent access to the Company's premises.
5. Your data will be processed solely for the purpose of the cooperation taking place between you and the Company, and for the purpose of enabling your entry and movement on the premises, in accordance with the Company's personal traffic rules, as well as for the purpose of demonstrating compliance with the Company's established procedures regarding the movement of persons In the event of future audits and inspections.
6. Your personal data may be transferred to entities located outside the European Economic Area (EEA) zone, i.e. located in Canada and in the United States of America under approved and applicable Binding Corporate Rules. 7. With your consent, the Company may obtain and use your image for identification purposes, by means of a badge (pass) (legal basis Article 6 (a) RODO*). Your consent to the processing of your personal data, for the above purposes, is voluntary and may not be the basis for unfavorable treatment of you, and may not cause any negative consequences to you, in particular, may not be a reason justifying the denial of access to the Company's premises.
8. The Company shall keep personal data for the period of limitation of claims that may arise between the parties. With regard to the processing of personal data, in connection with the monitoring system operating on the premises of the Company, personal data obtained in this manner shall be processed for a period of three months, from the date of the recording, unless otherwise stipulated by separate regulations.
9. **You have, to the extent provided by law, the right of access to the content of your data and the right to rectification, erasure, restriction of processing, the right to data portability, the right to object, the right to withdraw consent at any time without affecting the the legality of the processing (if processing is based on consent) that was performed on the basis of consent before its withdrawal.**
10. **You have the right to lodge a complaint to the President of the Office for Personal Data Protection if you consider that the processing of personal data concerning you violates the provisions of the RODO.**
